Michael Lavelle-Jones
President RCSEd

Mr Lavelle-Jones was born and raised in North Wales then went on to undergraduate medical education at the University of Liverpool, where he qualified in 1977. After spending his early years training in Liverpool and North West England, he became a Research Fellow at the University of California, San Diego, 1983–1986, before being appointed Lecturer in Surgery with Professor Sir Alfred Cuschieri at Ninewells Hospital and Medical School, Dundee, Scotland. From 1993 he was a Consultant Surgeon/Honorary Senior Lecturer in Dundee with an interest in surgical gastroenterology and paediatric surgery. His major interest was in postgraduate training and education and was Training Programme Director (1994–2002) for the Eastern Region in Scotland. In 2014 he became a Silver Scalpel award winner for Best UK Surgical Trainer, as nominated by trainees. He has been active with the Royal College of Surgeons of Edinburgh since 1996 and held successive roles as Convener of Examinations, Member of Council, Honorary Secretary, Vice President with responsibility for international affairs and was elected President of RCSEd in 2015.



Mona Guckian Fisher

A registered nurse with post graduate Diploma in Theatre Nursing. Mona has extensive experience in perioperative practice involving many specialties and predominately within the disciplines of Trauma and Cardiothoracic. She has been active with the Association for Perioperative Practice (AfPP) for many years serving on the Governance committee and the Board as a Trustee. She is the current President of the Association and represents AfPP nationally and internationally. Her special interests include patient safety, human factors and staff welfare and the legal and ethical aspects of perioperative practice. She achieved a Master's degree (with Commendation) in Health Law (LLM) from Nottingham Trent University and provides support as an expert witness to the legal profession and advice and support to the NHS and independent healthcare sector.

As a consultant he was the lead clinician for the implementation of Scotland's first integrated hospital information system. He has also had a significant interest in training and is training programme director for orthopaedics in the West of Scotland. He is an Honorary Clinical Associate Professor in the University of Glasgow and currently chairman of the SAC for trauma and orthopaedics.

Upcoming Faculty of Perioperative Care Courses

Surgical Anatomy Study Day for Perioperative Practitioners (Principles of Surgical Anatomy)

6 February 2017, Edinburgh

Target audience: Perioperative Practitioners (Surgical First Assistants and Surgical Care Practitioners)
Providing an introduction to principles of surgical anatomy as well as an overview of the structure of the body as a whole, as a basis for further study. The course will consist of short, illustrated introductory talks using case studies followed by interactive, cadaveric demonstrations, taught by experienced tutors. These sessions will place a particular emphasis on demonstrating the form and relationships of structures of surgical significance in three-dimensions.

Perioperative Care Practitioners Intraoperative Non-Technical Skills (PINTS)

5 May 2017, Birmingham

Target audience: Perioperative Care Practitioners (PCPs) and Surgical First Assistants (SFAs)
Perioperative care practitioners (PCPs) and surgical first assistants (SFAs) will improve their intra-operative performance and observe and rate intra-operative non-technical skills. You will recognise the importance of non-technical skills of all team members during operative surgery, discuss the underlying principles of the non-technical skills which underpin good surgical performance as it relates to scrub practitioners, surgical first assistants, surgical care practitioners and identify and rate these cognitive and social skills using a taxonomy of behaviours.

Surgical Anatomy Study Day for Perioperative Practitioners (Surgical Anatomy of the Trunk)

30 May 2017, Edinburgh

Target audience: Perioperative Practitioners (Surgical First Assistants and Surgical Care Practitioners) who have already attended the Principles of Surgical Anatomy Study Day
This study day provides an overview of the surgical anatomy of the trunk (thorax, abdomen, pelvis and perineum) as a basis for further study. The course will consist of short, illustrated introductory talks using case studies followed by interactive, cadaveric demonstrations, taught by experienced tutors. These sessions will place a particular emphasis on demonstrating the form and relationships of trunk structures of surgical significance in three-dimensions.

Leadership and Development

TBC, Edinburgh

Target audience: SCPs, SFAs, Trainee SCP or SFAs, Nurses and ODPs
Participants will develop self-awareness of their learning styles, individual strengths and development needs. It will discuss service improvement including writing business cases, time management and work life balance.
